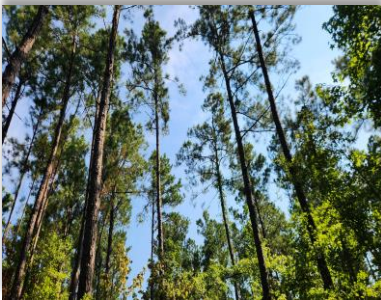

Scan for Driving Directions



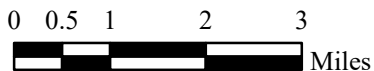
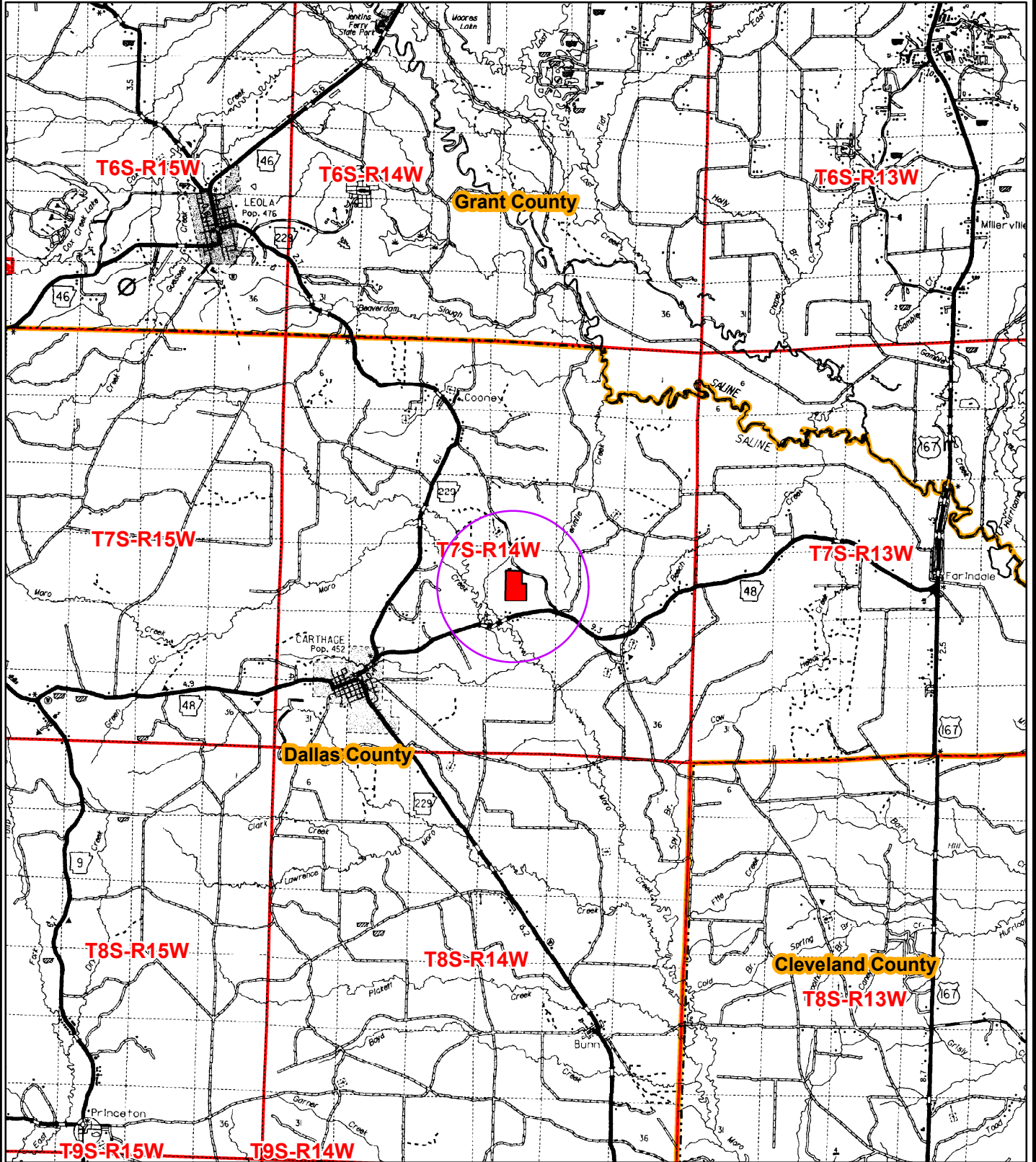
PROPERTY DESCRIPTION

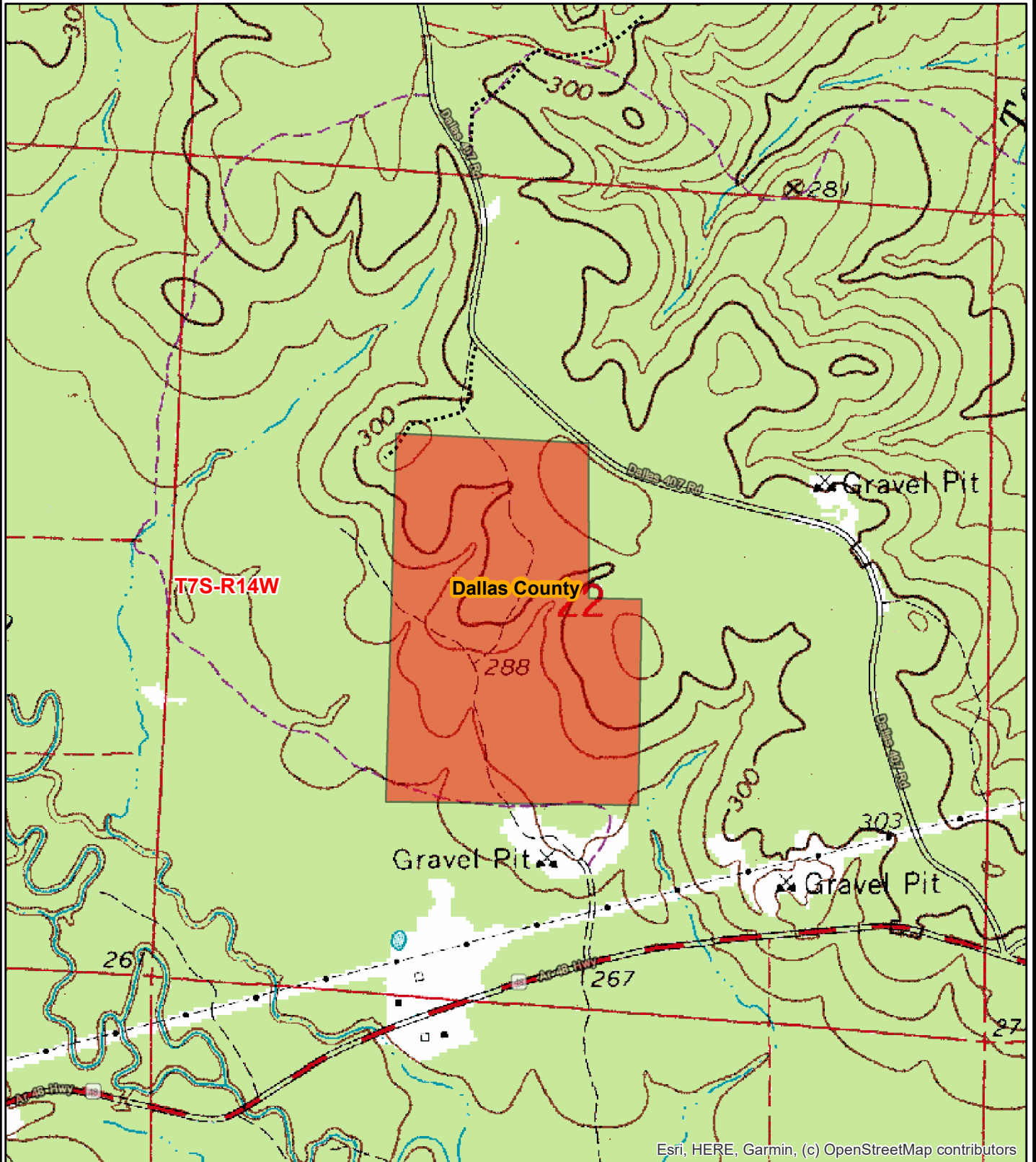

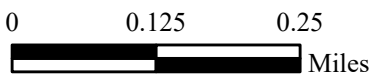
