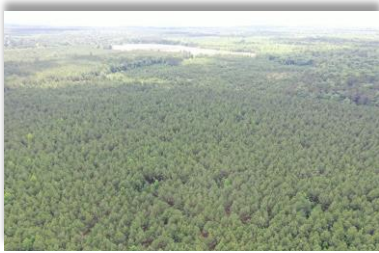

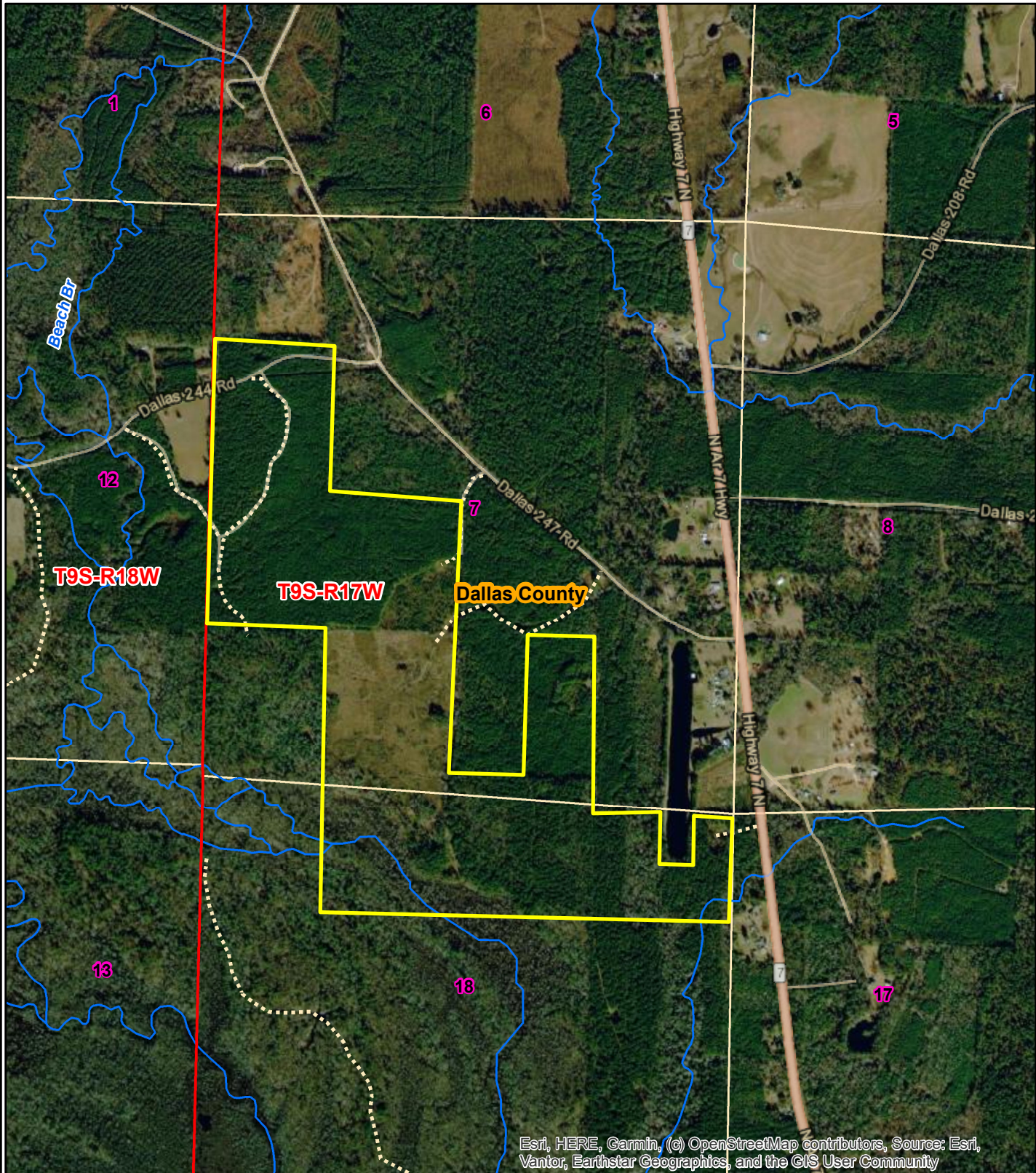


PROPERTY DESCRIPTION

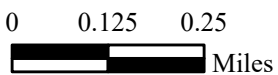

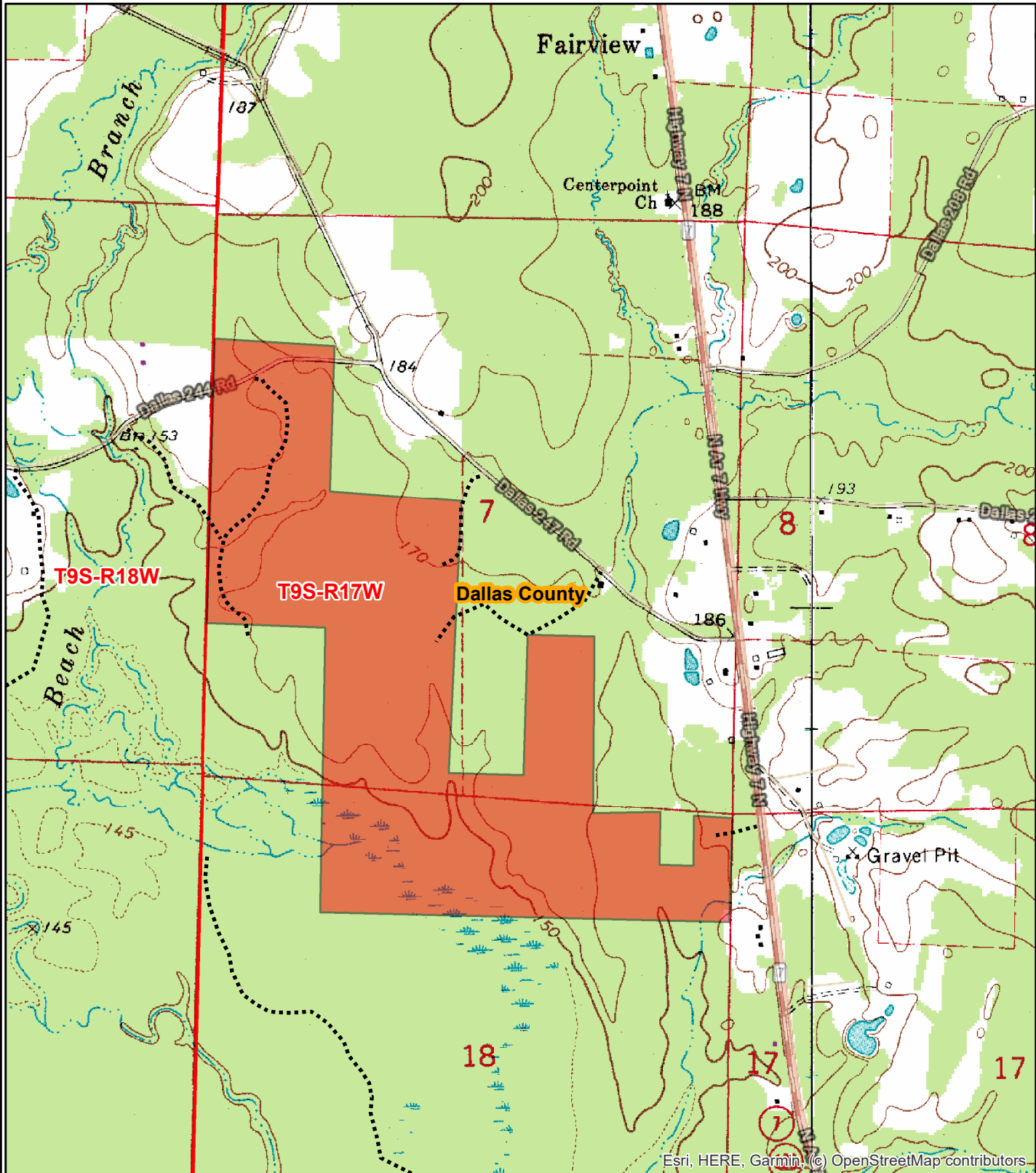

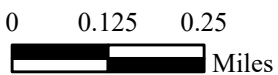
