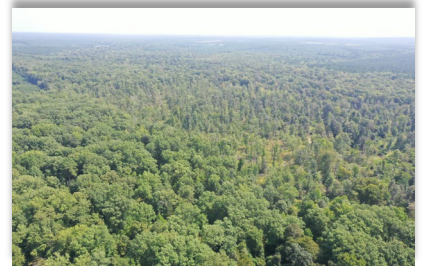

PROPERTY DESCRIPTION

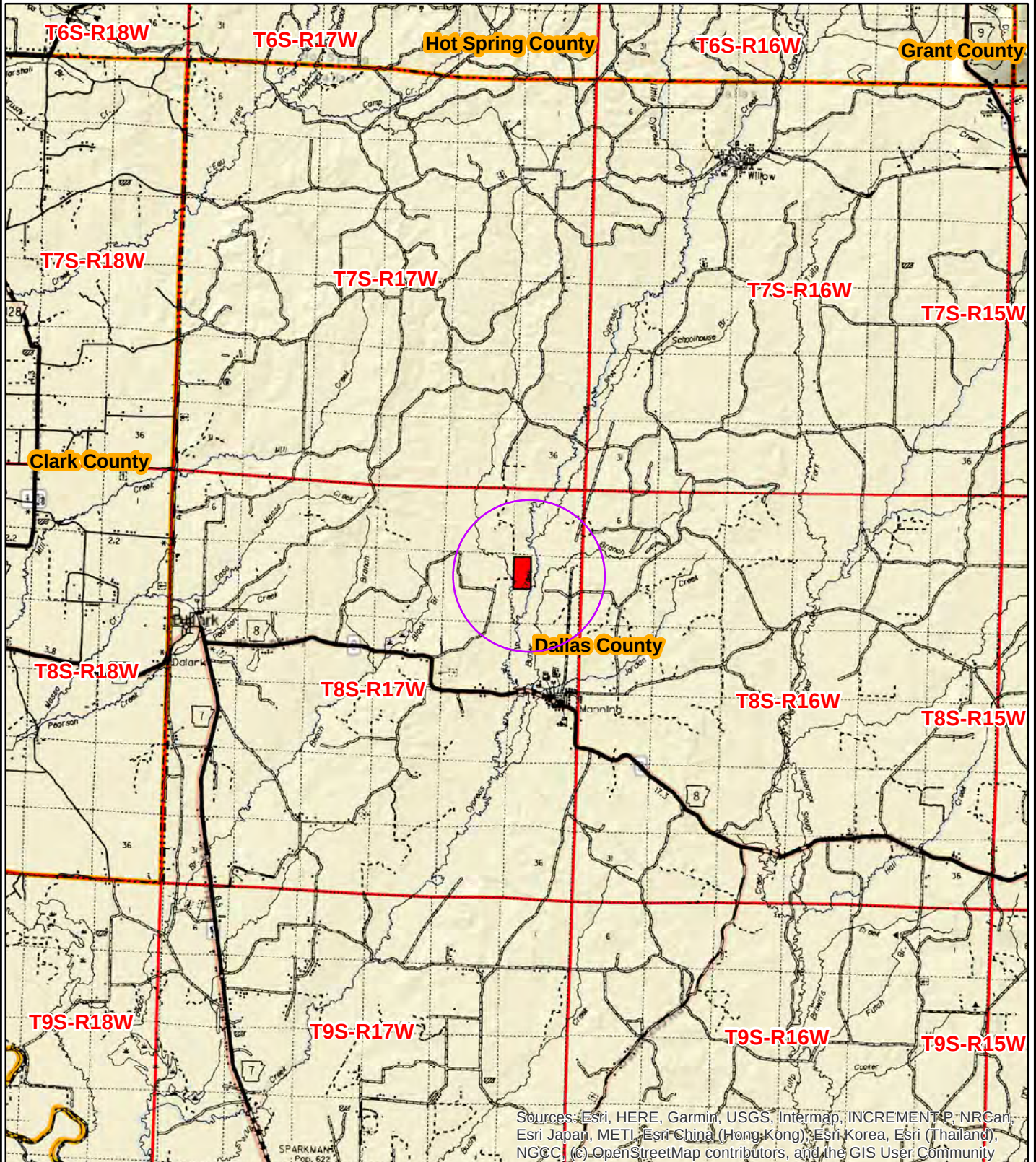

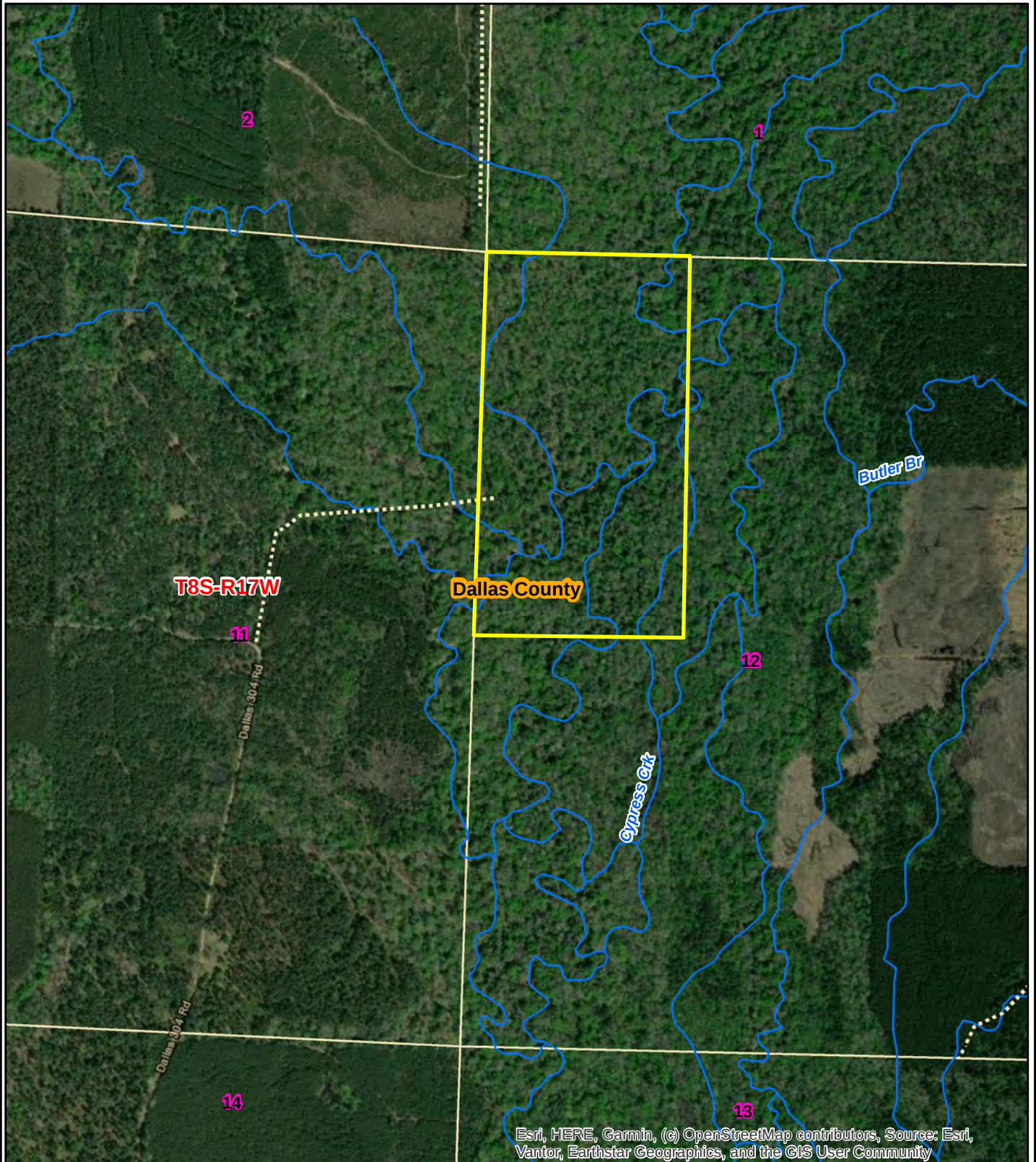

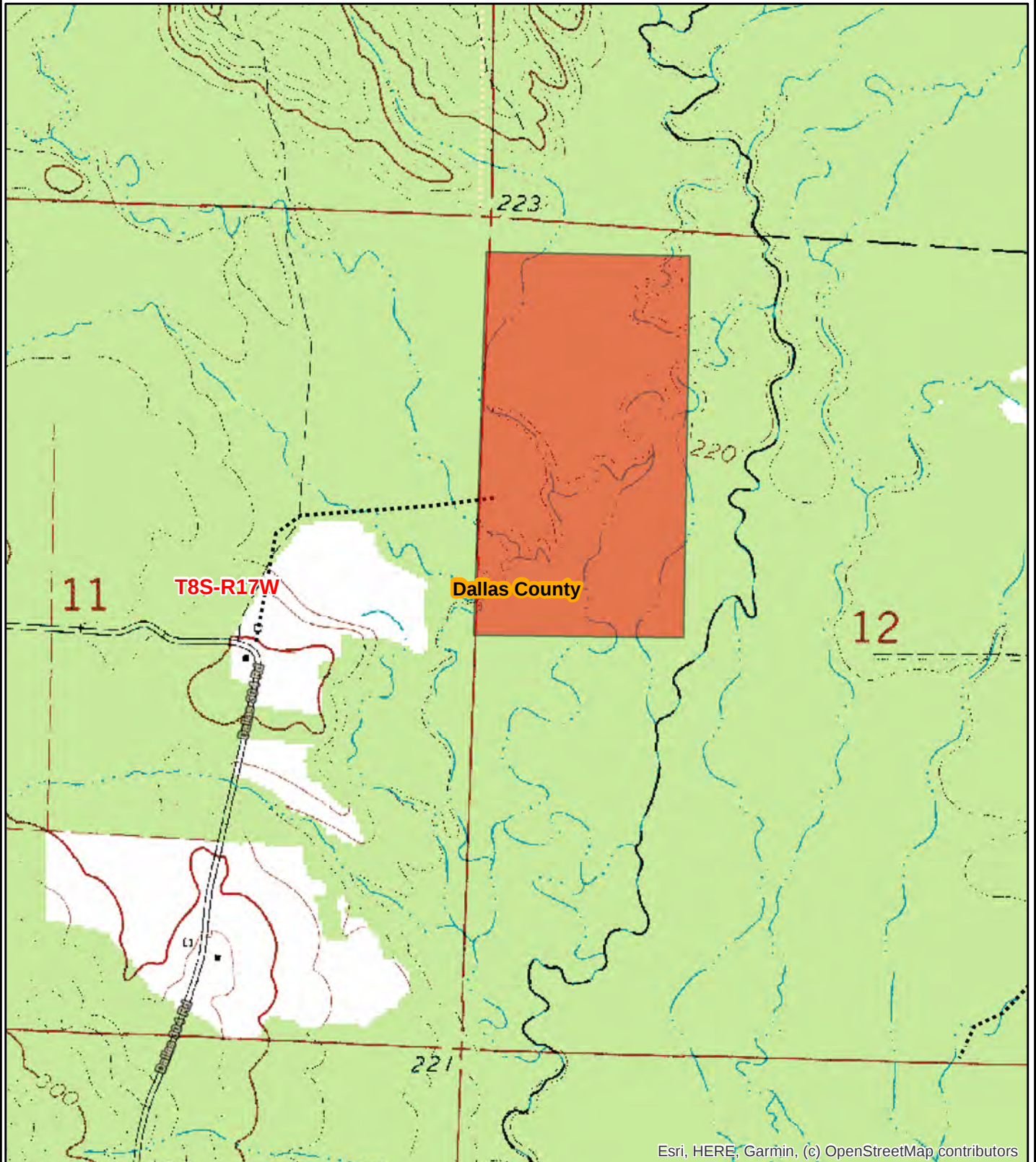
