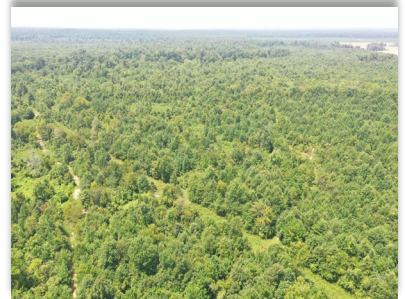
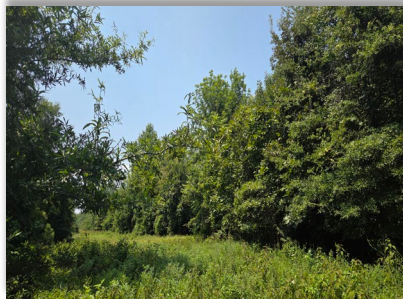
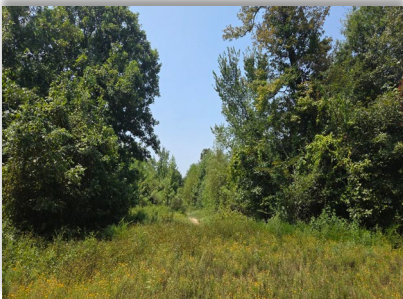

PROPERTY DESCRIPTION

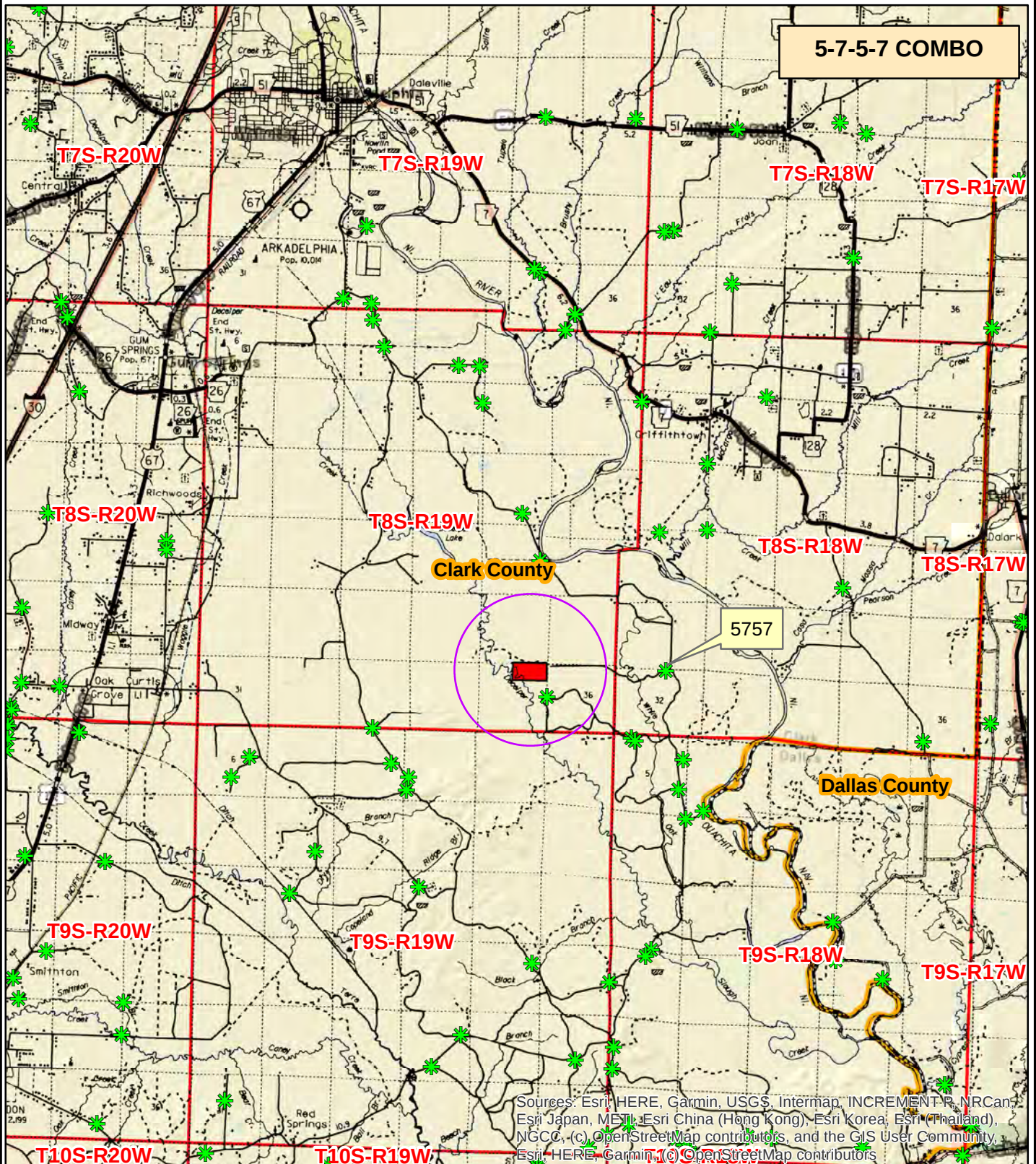

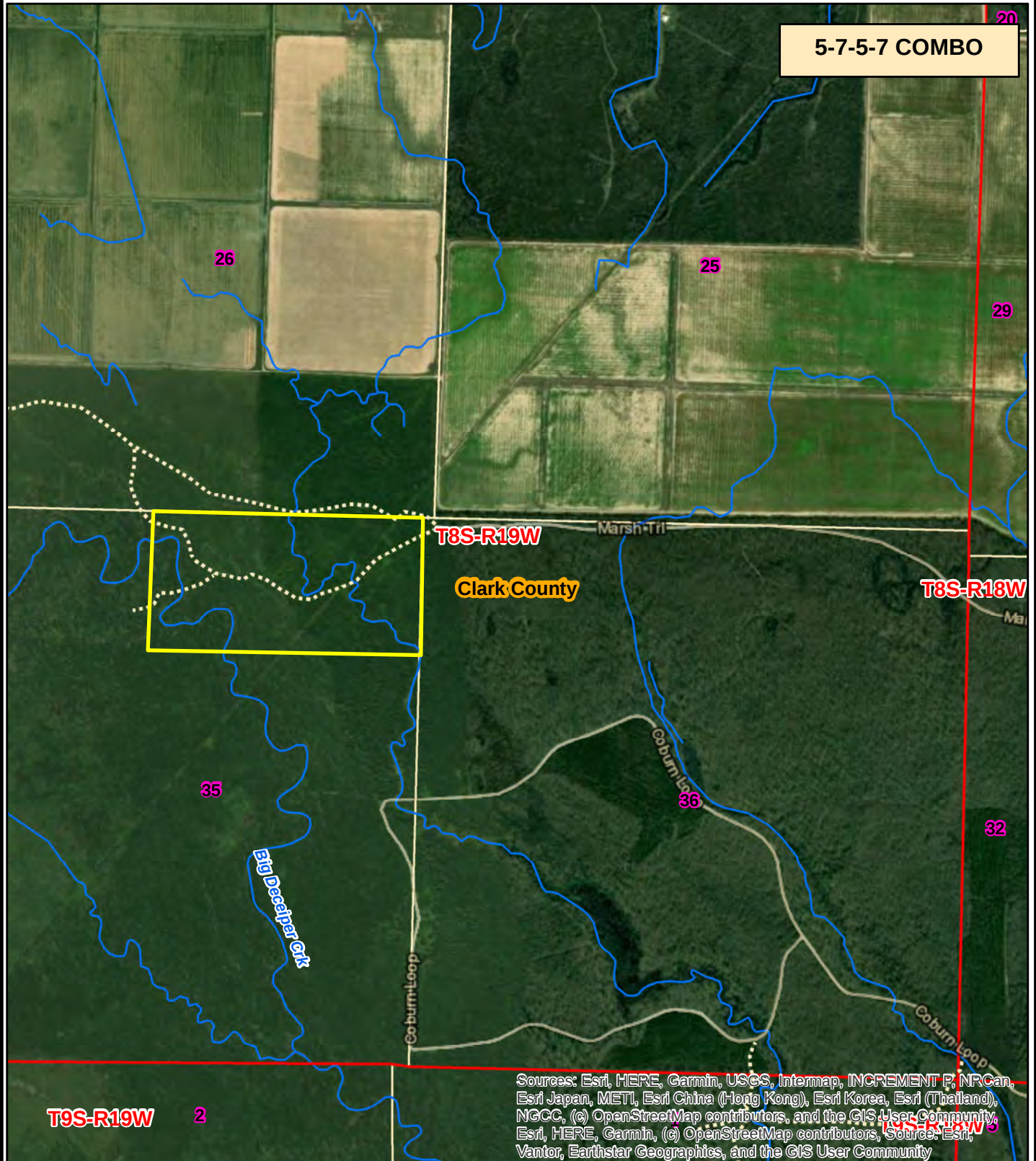

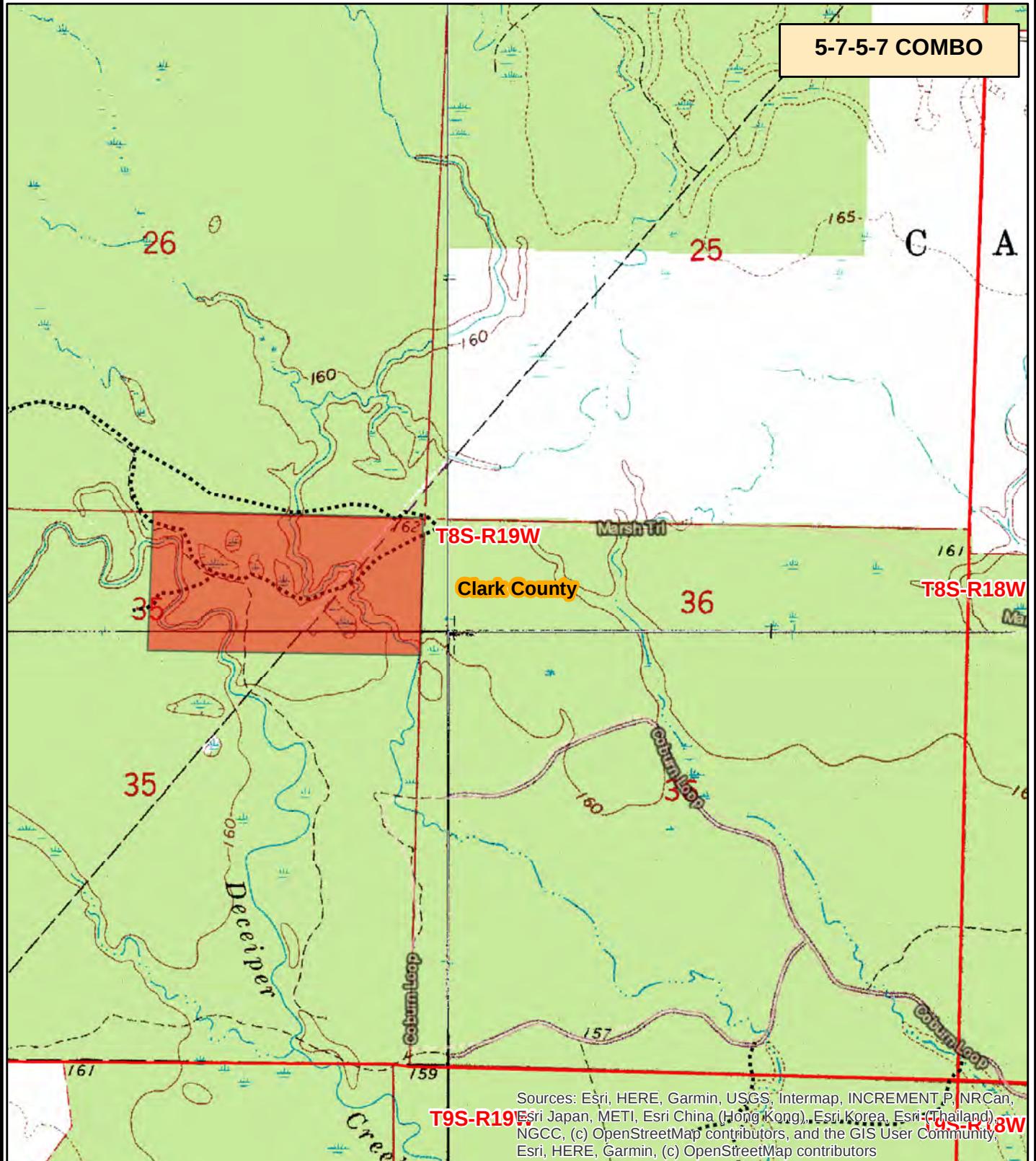
