The tract is located about six (6) miles southeast of Donaldson, and eleven (11) miles east of Arkadelphia, Arkansas. Access is woods road via Pump Station Road. Site index for loblolly pine averages eighty-four (84) feet (base age 50) on Smithton-Pheba and fine sandy loam soils. Timber consists of ±2006 pine plantation and is ready to thin with a mix of pine products. Tract offers opportunity for immediate timber income, hunting / recreation, and is an excellent timber investment property.

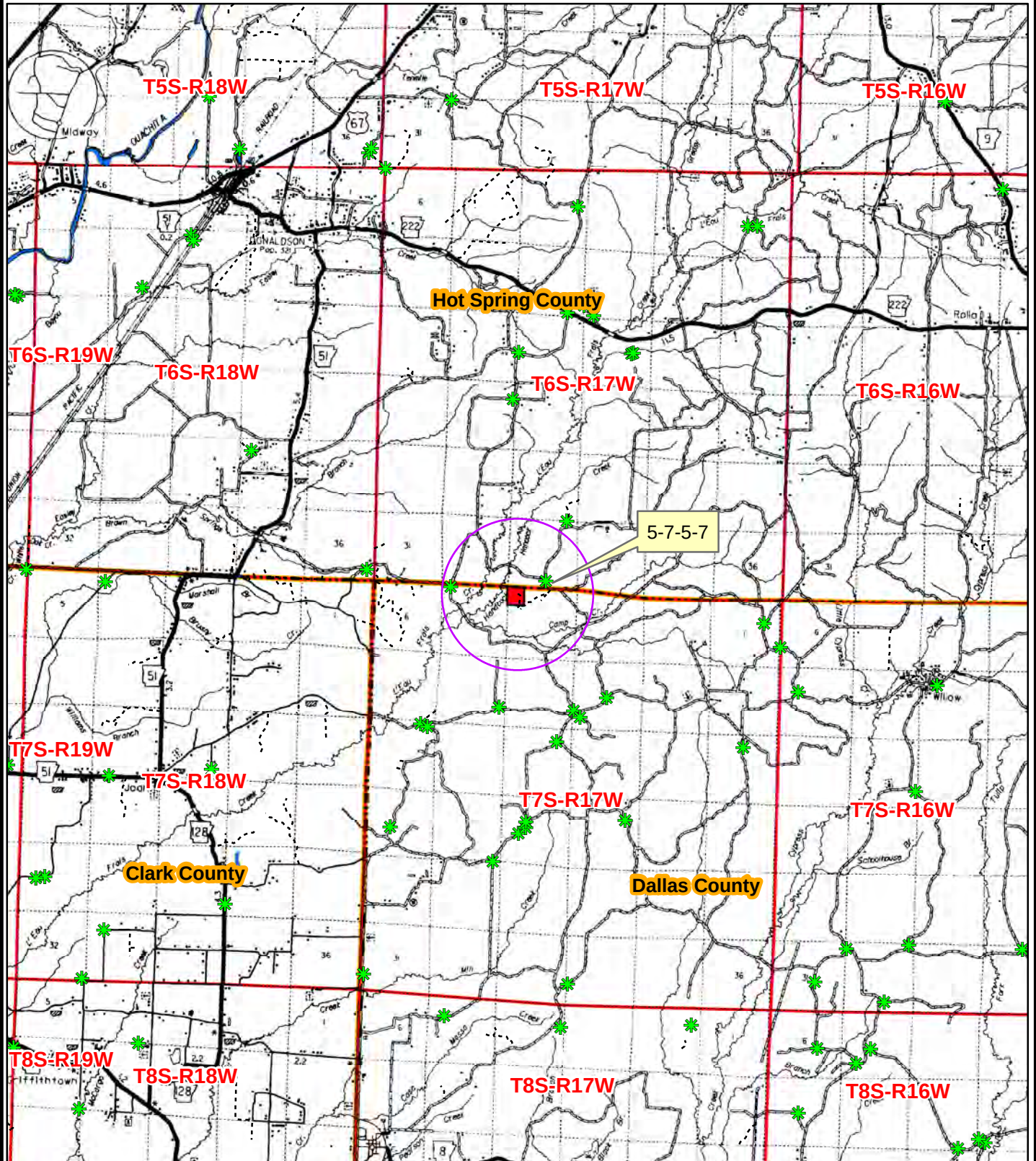

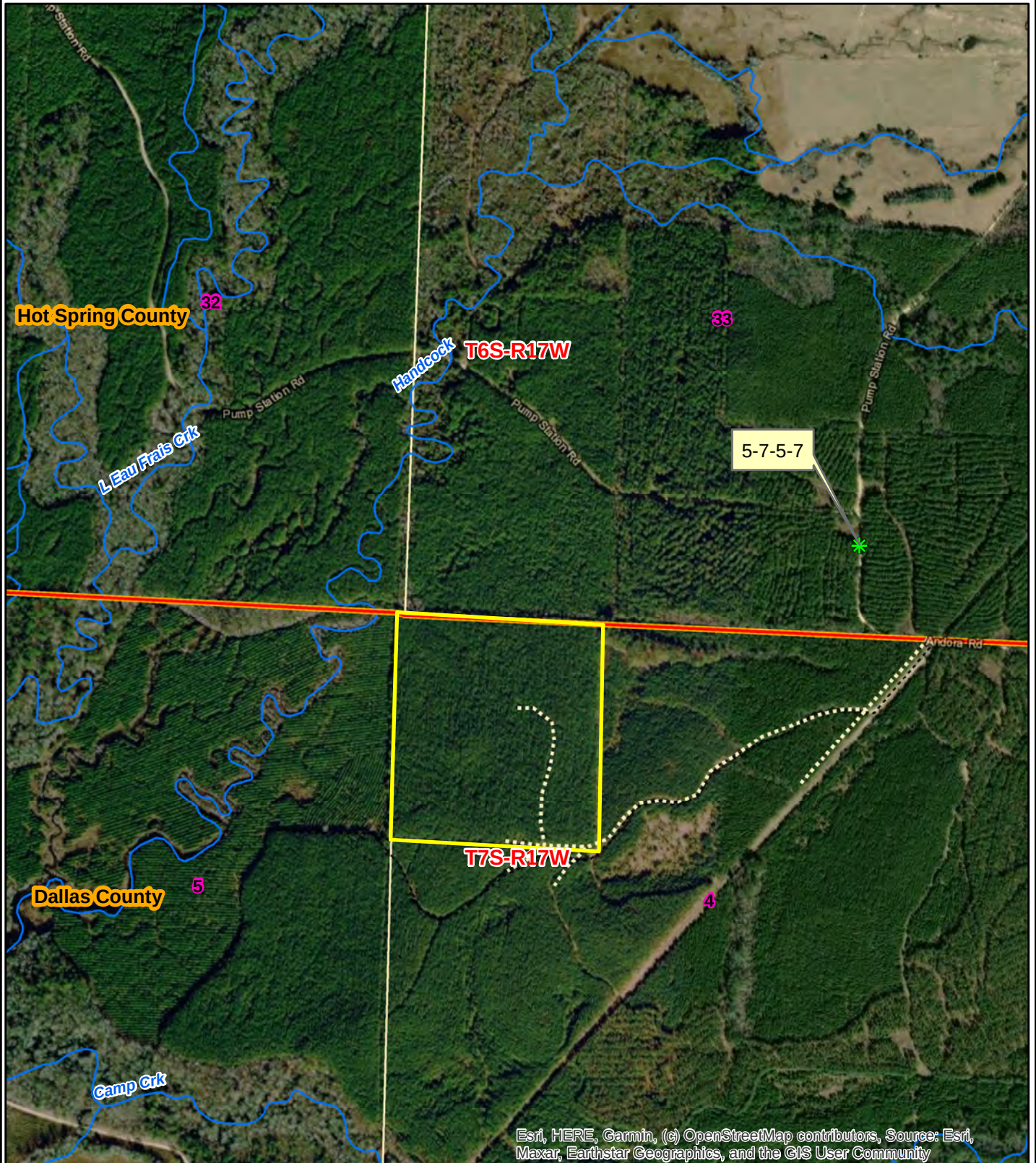

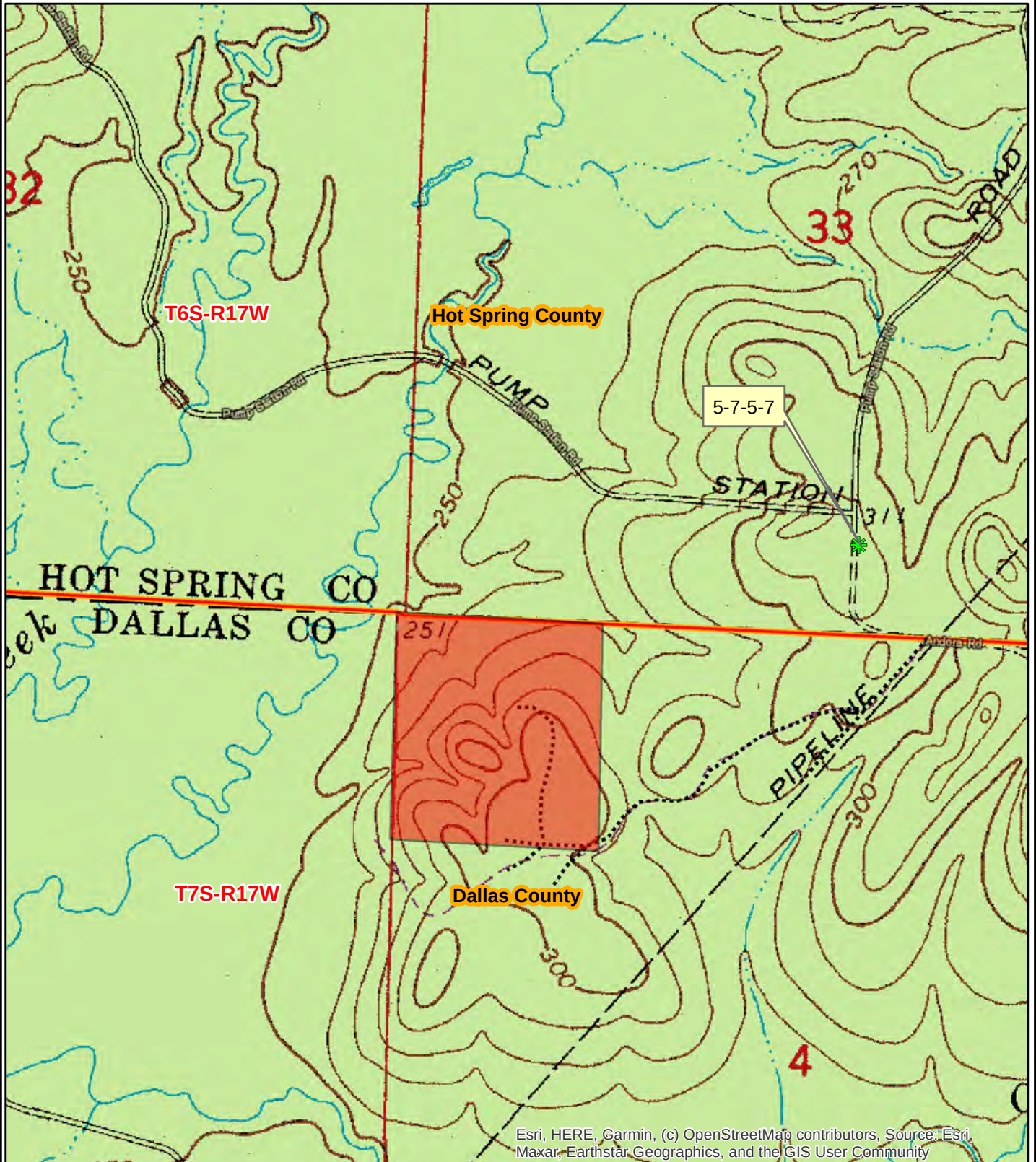
